

**Grant Township Monthly Board Meeting**

August 12, 2020

The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

Board members present: Supervisor Gil Archambo, Clerk Toinelle Brasseur, Treasurer Rachel Vallance, Trustee Elyn Kallio and Trustee Eric Boyd. 3 general public members were in attendance.

The pledge was recited by all.

Addition to agenda: Water Hydrant – add to Old Business

Motion to accept the agenda with additions: by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

Motion for the approval of minutes from the July 14th, 2020 meeting with corrections; by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

- Clerk's report: Absentee ballots 219 sent, 175 ballots returned, 3 ballots received after Election Day. 104 voters voted in the precinct. Shower curtains worked well, only one person complained about wearing a mask.

Treasurer's report: Municipal Money Market cash on hand as of 6/30/2020 was: \$106,179.93. July deposits were: \$14,327.61 and with a transfer to Checking of \$28,080.00; with a balance on hand as of 7/31/2020 of \$92,427.54.

General Fund Checking cash on hand as of 6/30/2020 was \$0.98. July interest was \$0.65. July deposits were \$28,080.65. July disbursements were \$28,079.46, for a balance on hand as of 7/31/2020 of \$2.17.

Municipal Money Market worth as of 7/31/2020 was \$92,427.54. General Fund Checking worth was \$2.17, and Investments on Deposit as of 07/31/2020 was \$166,822.56 for a total net worth of \$259,252.27, which is \$11,327.95 more than the total worth this month last year.

Motion to approve the Treasurers report: by Trustee Boyd, supported by Trustee Kallio All approved, motion carried.

Public Comment: D. Berden- the outhouses located at Grant Township Hall is in dire need of repair, roofs need repaired, paint needs scraped and repainted.

Old Business: Water Hydrant- will need to speak with Gary Williams of the Alverno Fire Department regarding a hydrant at the bridge. Gil will ask him to come to a meeting to discuss. Question also arose, is the one at the end of Ross road maintained? The resurface of parking lot was also brought up. Gil was to contact contractor for resurface next week. Board also spoke of Blight ordinance, and what has to happen. Supervisor (or appointed board member) would be contact with officer appointed to our township, per the paper the township would be responsible for court fees, and any overtime occurred by the officer. This will be put on the next meeting agenda.
