Treasurer's report: Municipal Money Market cash on hand as of 9/30/2020 was: \$84,448.74. October deposits were: \$6.17 and with a transfer to Checking of \$16,471.00; with a balance on hand as of 10/31/2020 of \$67,983.91.

General Fund Checking cash on hand as of 9/30/2020 was \$.37. October interest was \$.39. October deposits were \$16,471.39. October disbursements were \$16,470.91, for a balance on hand as of 10/31/2020 of \$0.85.

Municipal Money Market worth as of 10/31/2020 was \$67,983.91. General Fund Checking worth was \$0.85, and Investments on Deposit as of 10/31/2020 was \$16,737.08 for a total net worth of \$235,321.84 which is \$16,841.00 more than the total worth this month last year.
