- Municipal Money Market cash on hand as of 4/30/17 was \$95,418.70. May deposits were \$20,425.36. Transfer to General Checking was \$15,597.54 for a balance on hand as of 5/31/17 of \$100,246.52
- General Fund Checking cash on hand on 4/30/17 was \$.95. May deposits were \$15,597.76. Total disbursements were \$15,597.54 for a balance on hand as of 5/31/2017 of \$1.17.

• Investments remained the same for a balance on hand as of 5/31/17 of \$160,949.10 for a total worth of \$261,196.79 which is an increase over last year's balance at this time of \$240,511.51.
