Treasurer's report: Municipal Money Market cash on hand as of 4/30/2020 was: \$114,062.67. May deposits were: \$23,342.94 and with a transfer to Checking of \$10,408.00; with a balance on hand as of 7/31/2020 of \$126,997.61.

General Fund Checking cash on hand as of 4/30/2020 was \$1.11. May interest was \$.29. May deposits were \$10,408.29. May disbursements were \$10,408.18, for a balance on hand as of 5/31/2020 of \$1.22.

Municipal Money Market worth as of 5/31/2020 was \$126,997.61. General Fund Checking worth was \$1.22, and Investments on Deposit as of 05/31/2020 was \$166,316.01 for a total net worth of \$293,314.84, which is \$18,273.97 more than the total worth this month last year.
