

## Grant Township Monthly Board Meeting

September 10, 2019

The Grant Township monthly board meeting was called to order at 6:00 by Supervisor Archambo. Present were: Supervisor Archambo, Clerk Brasseur, Treasurer Vallance, Trustee Kallio and Trustee Boyd. 4 general public members were in attendance.

Treasurer's Report:

Municipal Money Market cash on hand as of 7/31/19 was: \$83,001.19. August deposits were: \$2,618.44 and with a transfer to Checking of \$13,570.00; with a balance on hand as of 7/31/19 of \$72,049.63.

General Fund Checking cash on hand as of 7/31/19 was \$1.65. July interest was \$0.22. July deposits were \$13,570.22. July disbursements were \$13,569.51, for a balance on hand as of 7/31/2019 of \$2.36.

Municipal Money Market worth as of 7/31/19 was \$72,049.63. General Fund Checking worth was \$2.36, and Investments on Deposit as of 7/31/19 was \$164,921.48 for a total net worth of \$236,973.47, which is \$12,302.13 more than the total worth this month last year.
