General Fund Checking cash on hand as of 7/31/2020 was \$2.17. August interest was \$0.26. August deposits were \$13,206.97. August disbursements were \$13,208.58, for a balance on hand as of 8/31/2020 of \$0.56.

Municipal Money Market worth as of 8/31/2020 was \$81,657.17. General Fund Checking worth was \$0.56, and Investments on Deposit as of 08/31/2020 was \$166,822.56 for a total net worth of \$248,480.29, which is \$11,506.82 more than the total worth this month last year.
