The Grant Township board meeting was called to order at 6:00pm by Trustee Boyd.

Board members present: Clerk Toinelle Brasseur, Treasurer Rachel Vallance, and Trustee Eric Boyd.
Absent; Supervisor Gil Archambo and Trustee Elyn Kallio. 2 general public member was in attendance.

Addition to agenda: approval or changes to the 2021/2022 budget

Motion to accept the agenda: by Treasurer Vallance and supported by Clerk Brasseur. All approved, motion carried.

Motion for the approval of minutes from the February 9, 2021 meeting; by Treasurer Vallance and supported by Clerk Brasseur. All approved, motion carried.

Clerks Report: Recent changes with the governors orders allows gatherings of up to 25 people indoors while wearing masks. Residents have been inquiring on renting the hall, Clerk Brasseur is asking the board if we can grant reservations following the Governors guidelines. Treasurer Vallance and Trustee Boyd agree that we should be able to rent the hall, as long as the residents know we need to follow the governor's orders regarding Covid-19 pandemic.

220 absentee applications are being processed to send out for the May 5, 2021 election.

Treasurer's report: General IMMA cash on hand as of 1/31/2021 was: \$79,167.92. February deposits were: \$5.71 and with a transfer to Checking of \$7,687.00; with a balance on hand as of 1/31/2020 of \$71,486.63.

General Fund Checking cash on hand as of 1/31/2021 was \$1.09. February interest was \$.66. February deposits were \$7,687.66. February disbursements were \$7,356.84 for a balance on hand as of 2/28/2021 of \$331.91.

Municipal Money Market worth as of 2/28/2021 was \$71,486.63. General Fund Checking worth was \$331.91, and Investments on Deposit as of 2/28/2021 was \$167,855.70 for a total net worth of \$239,674.24, which is \$6,723.72 more than the total worth this month last year.

Motion to approve the Treasurers report: by Clerk Brasseur and supported by Trustee Boyd, All approved, motion carried.
