The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Gil Archambo, Clerk Toinelle Brasseur, Treasurer Rachel Vallance, Trustee McManus and Trustee Eric Boyd. 6 general public members were in attendance.

Addition to agenda: PIE&G new meter letter (New Business)

Clerks Report: May 4th election for the Special Education Millage passed with 68% of voters, Grant Township had a total of 134 voters, 104 absentee ballots and 30 in person voters.

Treasurer's report: General IMMA cash on hand as of 3/31/2021 was: \$184,839.97. April deposits were: \$8019.15 and with a transfer to Checking of \$70,065.00; with a balance on hand as of 3/31/2021 of \$122,794.12.

General Fund Checking cash on hand as of 3/31/2021 was \$11.50. April interest was \$.73. April deposits were \$70,065.73. March disbursements were \$70,075.87 for a balance on hand as of 4/30/2021 of \$1.36.

Municipal Money Market worth as of 4/30/2021 was \$122,794.12. General Fund Checking worth was \$1.36, and Investments on Deposit as of 4/30/2021 was \$167,982.38 for a total net worth of \$290,777.86, which is \$10,398.07 more than the total worth this month last year.
